NTU LEGAL UPDATE— WHY AN NTU BUILDING REPRESENTATIVE AND NTU BUILDING COMMITTEE IS AN ABSOLUTE NECESSITY WITHIN EVERY NEWARK SCHOOL AND FACULTY

An NTU Building Representative and NTU Building Committee are an absolute necessity within every Newark school. Every teacher, aide, and clerk must understand they are part of a faculty and must be unified to attain success. In unity of purpose there is collective strength which leaves no faculty member alone and defenseless.

Insure your school has an NTU Building Representative and NTU Building Committee. A faculty is defined as: A GROUP CONCERNED WITH A MAJOR DIVISON OF KNOWLEDGE AND VIEWED AS A BODY. (Emphasis supplied)

A school faculty has as its goal the education and welfare of the students in its care. A faculty must be provided the tools to accomplish its mission. (Class size, aides, equipment, prep periods, books, proper classification of students, CST and guidance services, proper environmental conditions, etc.). The Newark Board of Education has the statutory responsibility to provide a faculty with the tools to succeed. Unless the Newark Board of Education knows of deficiencies within schools and is requested to correct them by the NTU the faculty can be held responsible for continuing deficiencies because of faculty inaction as will the school administration who will pass the buck to you! Too often school administrations have blind eyes to what is wrong in the buildings.

Your NTU Building Representative and NTU Building Committee are the initial "go to" people to bring forth the deficiencies which hamper the success of classroom and overall building achievement. Use them. Document, in writing, deficiencies to your Building Rep and keep a copy for yourself.

It does you no good to gripe to yourself or the next door teacher when you haven't taken the initiative to address your issue with your NTU Building Representative who, with your NTU Building Committee, can address your issue professionally and collegially with your administration. Your building faculty must have a "unity of concern" over every school deficiency which can be reasonably corrected and which must be documented in writing or email to your school administration. Remember, if deficiencies are not made known to administration through the NTU Building Representative and NTU Building Committee, you will be told by administration "how are we to know when you never took the time or the effort to tell us" and you could wind up being the fall guy! It happens too often! Insure your school has a NTU Building Rep and NTU Building Committee. Call Michael Maillaro at 973-643- 8430.
