N.J. finally has graduation rules for freshmen and sophomores, and students probably love them

New Jersey's long debate over graduation requirements for current freshmen and sophomores finally appears to be over, and students won't have to pass the standardized test formerly known as PARCC in order to graduate from high school.

The state Department of Education on Wednesday announced it resolved a legal challenge by agreeing to extend the graduation rules for juniors and seniors for two more years.

The move allows current freshman and sophomore students to pass an alternative exam in math and English, such as the SAT or ACT, rather than the state standardized test, which is now called the New Jersey Student Learning Assessment (NJSLA) but closely resembles the controversial PARCC tests.

Students who pass NJSLA tests can also use them to meet the state's standardized testing requirement.

The decision creates continuity through the Class of 2022 as Gov. Phil Murphy's administration continues to search for a new standardized test and considers the role of testing in graduation standards. It also resolves a legal challenge from the Education Law Center and American Civil Liberties Union of New Jersey, which successfully had the state's graduation requirements struck down by a court last year.

"(This) will provide clear pathways to graduation for all current high school students," the Education Law Center said in a statement.

For now, the agreement brings peace to what has been a highly contentious issue that angered parents and confused both students and school officials.

State law says all students must pass a standardized test in English and math during 11th grade in order to graduate from high school. New Jersey administered such an exam for years but stopped when the PARCC tests debuted during former Gov. Chris Christie's administration.

Christie's state Department of Education announced students would eventually need to pass PARCC exams in Algebra I and 10thgrade English to meet the graduation testing requirement. And it created a "menu" of other tests, such as the SAT, that students in graduating classes through 2020 could use as the state transitioned to the new assessments.

The problem was none of those exams were exclusively given in 11th grade, and the state law was never changed to reflect what the state Department of Education was mandating.

The Education Law Center and ACLU sued on behalf of several civil rights groups and won, putting the state on the brink of a graduation crisis: It had a rule on the books but no test in place to enforce it.

State officials came to a compromise in February for the graduation rules for juniors and seniors prior to the agreement announcement Wednesday for freshmen and sophomores.

The deal was approved by the Superior Court, Appellate Division, according to the Education Law Center.

Bill would erase N.J. pensions for certain crimes

A bill headed to Gov. Phil Murphy's desk would strip public workers and elected officials of their pensions if they're convicted of certain sexual misconduct offenses or corruption in connection with their public employment.

The bill (A3766) passed by the state Senate, 37-0, on Thursday adds sexual assault, sexual contact, lewdness and public corruption to the list of existing offenses that can cost employees their retirement benefits.

"Anyone who has the audacity to use their taxpayer-funded position of power to assault a coworker doesn't deserve a state pension," Sen. Kristin Corrado, R-Passaic, said in a statement. "Public service is about helping people and making the state you work for a better, safer place for all. <u>Anyone who commits a crime that is contrary to that</u> mission, whether it's an ethics violation or a sex offense, shouldn't be paid by the state for life."

Some crimes that could already result in a worker forfeiting their pension include money laundering, extortion, bribery, perjury, official misconduct and tampering with public records. These offenses must also in some way be tied to an individual's public employment.

The bill has been amended from its original version, which included harassment as a crime warranting a forfeited pension. The original version also did not include the public corruption offense.

Assemblyman Michael Patrick Carroll, R-Morris, had expressed concern with attaching such a severe penalty to an offense like harassment, which is typically classified as a petty disorderly persons offense — and not a crime — in New Jersey.

The final version of the bill includes convictions of public corruption of public resources in the first degree, which it defines as "when a person knowingly uses or makes disposition of a public resource valued at \$500,000 or more for an unauthorized purpose ..."

The state Assembly passed the bill 79-0 in September.
