Getting Our Voice Back



Since returning to local control, one of the NTU's top goals was to ensure that the NTU and our members always have a seat at the table. We started this process by reorganizing the Peer Oversight Committee to become the Framework Evaluation Committee. Half of the FEC are NTU-appointed members, and the FEC has made recommendations to Superintendent León on how to improve the Evaluation Framework and the implementation of the Evaluation Framework.

This week, NTU members were asked by the Superintendent to review seven revised district

policies and make their recommendations for how to improve these policies. The areas covered included extracurriculars, discipline, attendance, student dress code, graduation, grading, and promotion/retention. The NTU feels strongly

that it is important to provide well-researched alternatives that come from experience and best practice, not just saying no for the sake of saying no.

Progress has been steady. NTU will have two members on the district's environmental impact committee, and several NTU members will be meeting with the Superintendent in the coming weeks about how to reduce unnecessary mandates and paperwork.

Our credo is "Everything that has to do with Education is our domain!" We will continue reporting out our successes, and the challenges to getting there.

Rebuttals



I cannot stress enough the importance of writing a RE-BUTTAL to your observation if you are dissatisfied with ANY part of it. Sometimes, you like the overall score, but don't like one of the ratings. **Do NOT let that go!**

You have ten work days after the receipt of your ratings via a post-observation conference to submit your rebuttal. If you do not submit a rebuttal, then you are telling your admin and NPS that you

AGREE with the rating.

If your admin observes you in-between your initial observation and BE-FORE your post-observation conference, then you MUST notify us immediately and ALSO immediately write a rebuttal stating that you have been observed twice in a row without getting the necessary feedback to improve.

Your rebuttal MUST include actual evidence and MUST connect directly to the ratings in the competencies. Do NOT include anecdotal stories, and do not include personal attacks or personal problems with your administrators in your rebuttal. If you believe your administrator is "out to get you," then you should document your concerns and we will help you contact Labor Relations or the Office of Affirmative Action.

Rebuttals must be emailed to your admin, uploaded to your EdReflect, hardcopy delivered to your admin, and emailed to Human Resources at evaluations@nps.k12.nj.us.

Know your Rights—Prep Periods

In our new contract reached on August 2019, we increased the number of prep periods for elementary teachers, and clarified exactly how those prep periods can be used. This language was agreed by directly with Superintendent León and ratified by the Newark Board of Education:

Teachers shall have those periods during which specialists cover their classes set aside for preparation as defined in Article V, Section 5.A.8 of this Agreement. All elementary school teachers shall receive a minimum of five (5) preparation periods in a five (5) day week. **Three**

(3) of the five (5) weekly preparation periods shall be self-directed by the teacher. Two (2) of the five (5) weekly preparation periods shall be directed by the building administration for activities such as, but not limited to, grade level meetings and common planning.

The key phrase here is "<u>self-directed by the</u> <u>teacher."</u> If you are losing one of your "<u>self-directed"</u> prep periods to IEP meetings, mandates that have nothing to do with preparing for your classrooms, or any other purpose, that means you missed your prep period, and the administrator has to give you a make up prep in a timely fashion. Make sure you fill out a "missed prep form" and CC it to mmaillaro@newarkteachersunion.com.
