- Half your students didn't log in? Half your students don't have computers? Document it!
- Teaching outside of your certification? Document it!
- Being asked to cover for other classes? Document it!

Too often we find out about situations at schools long after they happen, which makes them very difficult to resolve, especially when there is documentation that your administrator was aware that the issue existed.

Keep your Building Rep in the loop, and if it can't be resolved at the school level, reach out to the NTU office.
