Change of working conditions for Child Study Teams, Court Representatives, Attendance Counselors and other impacted staff

The above staff can either do their duties as outlined in their job descriptions, or those staff can do the "charter school residency review" being asked of them. The staff cannot be expected to do both jobs in the

same time period. While we acknowledge that job descriptions are open ended and allow staff to be asked to do other tasks, that does not mean both jobs can be done at the same time.

We are happy to report that within 24 hours the Superintendent León and Assistant Superintendent Granato reached out to us to resolve this issue.

That said, throughout the pandemic, it seems like numerous admins have been trying to get blood from a stone, asking staff members to constantly do more while providing them with less supports. We continue to remind our members about the RSVP to Mandates process. THIS IS A VITAL PROTECTION WE FOUGHT FOR AND WON!
