### **President's Report**

#### Colleagues,

A few days ago, we were speaking to the President of another local teachers union, and that conversation helped put into perspective some of the successes we have had in recent years.

1) A terrific five-year contract with no givebacks. In light of how much the world has changed in the last year, having a five year contract with salary increases every year is a huge relief. No one wants to be negotiating a contract in the current climate.

While Congress is still debating the issue, we negotiated for our Per Diem staff

to make \$15 an hour since 2018, and got them another increase starting in 2021.

- 2) During state control, we came under heavy fire from corporate reformers that required us to expend tremendous funds to protect our members' legal and contractual rights. While we won pretty much all those legal challenges, there was still a huge cost. But we tightened our belts and made important changes to make sure that we could give back to the members and the community without having to look at raising Union Dues. The NTU stands stronger today than ever.
- 3) The NTU has also stood strong to ensure that remote learning continues until April. And we continue to meet weekly with the NBOE to ensure that when we do return to school, the safety of our school staff and students will never be compromised.
- 4) Expanded our members access to Employee Assistance through our work with HCAMS. HCAMS offers confidential services to individuals with substance abuse and other behavioral health problems that may be affecting their work, health and/or personal lives.
- 5) Increased member numbers and engagement! When many Unions have been seeing huge declines in membership after the Janus decision, the NTU has worked hard to expand our membership. We also have been putting strong Building Reps and Building Committees in as many schools as possible.

Thank you for your continued trust; allowing us to fight for and represent you. Standing Strong Together.

# NEWARK TEACHERS UNION UPDATE February 11, 2021 RSVP TO MANDATES

During this difficult time of remote learning, we are reissuing the "RSVP to Mandates Memo." For some background, back in 2011 -2012 the Newark Teachers Union filed complaints with the NBOE in an effort to address concerns over the abuse by certain administrators of insisting "district mandates" being due in an unreasonable amount of time.



At the time, then Superintendent Anderson, dismissed this legitimate issue & refused to discuss it. Our response was to produce and distribute the "RSVP to Mandates Memo" effectively absolving you of having to work beyond the workday. The NTU grieved the district's actions regarding the issue of paying its staff when directed by an administrator to work beyond the workday and won the attached arbitration award.

Before submitting this memo to your administrator, please discuss it with your Building Representative or NTU staff member.
