EVALUATION UPDATE

A couple weeks back we indicated our displeasure with how the district handled responses to annual rebuttals. Our Framework Evaluation Committee made recommendations to the Newark Board of Education on how to improve the process.

We are pleased to inform you that your concerns and ours were heard and changes have been made. Staff who filed rebuttals can now expect a reasonable response with detailed information as to how the determination was made whether to keep or change a rating.

It is vital for staff to do rebuttals on all Observations and Evaluations that they disagree with. Follow our <u>REBUTTAL WRITING TIPS</u>, for our comprehensive guide to writing a Rebuttal.

I am disappointed that the Responsible Collective Negotiations Act (<u>\$3810</u>/A5862) had to be pulled from the Senate and Assembly lists today because the votes were not there. This remains a work in progress, and our commitment to it must not waver.

As a teacher, this made me realize we need to spend the summer months educating members of the legislature about what this bill really is and what it does. And in doing so, we will counteract the false information that has been circulating.
