mSGP FAQ's – Some teaching staff may have received notice that their evaluation had been impacted by their mSGP (Median Student Growth Percentile).

What is mSGP? – A measurement used on teachers in PARCC tested grades to assess student growth level.



How does mSGP impact my evaluation? –

Under NJ law, mGSP (for impacted staff) makes up 30% of a teacher's evaluation. We had been able to get an equivalency waiver the last few years to hold that back from Newark. Our governor has spoken out against PARCC, so we are working with our union, community, and legislative contacts to minimize this impact moving forward.

What can I do to appeal my mSGP? – There is a process on the state's ACHIEVENJ website that can be used to appeal mSGP. <u>Click here for more information (page 2)</u>
