Two Different Schools, Same District (Part 1)

Colleagues,

As we return to somewhat normal, I have had the privilege of visiting more and more schools each week. As I was on my way to visit one school, I drove by another and heard sounds I had not heard in a while: the sounds of children frolicking in a playground. I turned the car around and made an unannounced visit to that school.

After going through the ingress protocols I came upon the school's Building Rep who volunteered to escort me to the Principal's office. His office was a good distance (it felt like 6 miles) away from the Main Office so I had the opportunity to chat with the Building Rep about the *return* and how it was going. The whole time I could hear joyful engagement. I do not have to describe that sound to teachers. Social and emotional wellness is not just for learning, it's for living!



When we reached the office, the Principal and Building Rep picked up on what sounded like an ongoing discussion about some scholastic issue or other. Apparently, whatever the issue was they were on the same page, and he confidently left the rest up to her. He offered me a seat and asked the reason for my visit and if there was anything he could do for me. I smiled and explained that I was only there for a wellness check and that the sounds of recess at a traffic stop had brought me there that morning. I thanked him and asked him to escort me out (remember, his office is 6 miles from the entrance). I had seen and heard everything I needed to see and hear: children being children, adults *in loco parentis* doing exceptional work under exceptional conditions together.

My point is this: whether it be scheduling recess during a pandemic or preparing for a live graduation ceremony under CDC, I witnessed a collaborative effort between professionals using the resources available to serve the interests of the students. It's not easy but it can appear effortless in an organization where power and trust is distributed widely and leaders can lead without being controlling.

Safe School Reopening Survey

It was announced this week that Newark is eligible for about \$262 million in COVID related federal aid. As is usually the case, the media is not quite reporting the story 100% correct. ELIGIBLE is the key word here. There are a lot of steps and procedures that need to be followed to make sure we get that money.



One of the biggest steps is that schools must have a Safe School Reopening Plan in place. Newark was one of the first districts in the country to have a Reopening Task Force. We have a strong Reopening Plan that has proven to be successful over the last few months. But, the plan has to be modified to ensure that all students and staff are 100% in person for full day instruction next year.

Next week, the district will be sending out a survey to all staff and stakeholders to help finalize the Safe School Reopening Plan. It is important that everyone take the time to do this survey. It should take about ten minutes of your time. Over the last few months, we have said over and over again “LEAVE NO DIME BEHIND!” \$262 million is money that can do a lot of good for our schools and the community, not to mention some very specific ideas we have discussed with the superintendent for our members.

IT'S TIME FOR YOUR EVALUATION! SHOULD YOU WRITE A REBUTTAL?

YES! In so many cases, staff who receive ratings they disagree with choose NOT to write a rebuttal. This can be because of several reasons. It can be out of fear of an administrator. You are non-tenured and do not want to make waves. You are approaching retirement and do not want to make waves. It's only one observation, you'll pick it up next time, etc etc.

WRONG.

This rating is **YOURS** for your entire career. If it's an annual, it **MAY** result in a withholding of an increment (one of the worst penalties an educator can take, it impacts your salary for the rest of your career) . It may also lead to a tenure charge (two years in a row of Partially Effective or Ineffective ratings can lead to you losing tenure and being fired). It can hurt your chances of transferring.

Without a rebuttal, there is almost no way to defend you from tenure charges. You are a professional, you went to school to do this job, and you should not want someone to mischaracterize your performance in a way you disagree with. **WRITE A REBUTTAL.** Click this link, [REBUTTAL WRITING TIPS](#), for our comprehensive guide to writing a Rebuttal.

Personal Days Buy Back and Roll Over

On Thursday, the district sent out the Personal Day Buy Back Forms. We have had a lot of questions about how personal days roll over or can be sold at the end of the school year. If you are eligible and did not receive one, or have any questions, please email the Payroll Team at payrollcs@nps.k12.nj.us. The forms MUST be in by June 30, with payment expected on July 30.



To be eligible, you must have used 5 or less sick and personal days during the 2020-2021 school years. Note that all sick days (including those used for FMLA) count towards that limit. Also note that under NJ stature, staff can only roll over 15 additional days each year, so if you have more than that, you should sell back your personal days or you will lose them!

ESCROW REMINDERS FROM NBOE

Dear Employee:

We hope that you and family are continuing to remain safe and healthy.

*This is a reminder for those enrolled in the Escrow Program that the deductions will be ending on **Friday, May 28, 2021**. The refund dates are as follows:*

*>>>One Check Option – issued in one (1) lump sum on **Friday, June 11, 2021***

*>>>Four Check Option – issued in four (4) equal installments on **July 9th**, 23rd, August 6th and August 20, 2021.*

*Escrow Open Enrollment –**May through July 15th** of each year, if you are interested in enrolling, switching options or discontinuing from the Escrow Program we ask that you do so through ESS (Employee Self Service). We are excited to introduce our ESS (Employee Self Service) way of enrolling in our Escrow Program this year!!*
